

Window Concepts of Minnesota, Inc. \$20,000 Home Makeover Sweepstakes Official Rules 2023

How to enter

Drawing

The potential winner will be contacted by phone and additionally sent written prize notification correspondence. The potential winner must comply with all instructions in the prize notification correspondence, including the completion of an affidavit of eligibility and liability/publicity release, and return them to Sponsor within fourteen (14) days of the date on the prize notification correspondence as well as have met all of the eligibility requirements set forth within these Official Rules.
